

Types of Permits Required

The Air Pollution Control Bureau issues permits for following projects:

Demolition With No Regulated Asbestos

The demolition and/or removal of a load bearing member of:

- commercial or industrial buildings,
- apartment buildings with more than four units, or
- if two or more residential structures are being demolished within a one block area and in the same fiscal year.

Demolition/Renovation With Regulated Asbestos Removal

The demolition and/or removal of a load bearing member of:

- commercial or industrial buildings,
- apartment buildings with more than four units, or
- if two or more residential structures are being demolished within a one block area and in the same fiscal year.

All regulated (friable) asbestos must be removed prior to the demolition.

Asbestos Removal Only

The removal of 260 linear feet or 160 square feet, or more, of regulated (friable) asbestos, even if the structure is not going to be demolished.

Friable asbestos is asbestos-containing-material (ACM) that can be reduced to a powder with hand pressure.

All asbestos removals, friable or non-friable, are required to be conducted by a company or individual certified by the State of Tennessee for asbestos removal.

State of Tennessee and TOSHA regulations may also apply.

Steps to Obtain a Permit

1. A **Ten Day Notification** form must be submitted at least ten (10) days prior to the beginning of the project. This can be found on our website at apcb.org
2. An asbestos survey is required for all demolitions, and most renovations, and should be submitted with the *Ten Day Notification*.
3. The **Ten Day Notification** and survey can be emailed to jschultz@chattanooga.gov or hand delivered to our office Monday – Friday between 8:00 a.m. to 4:30 p.m.

The demolition of a single-family dwelling does NOT require an asbestos survey or a permit from the Air Pollution Control Bureau providing it has not been used in the past for an institution, office, or commercial purpose.

5,000 and up	\$1,250

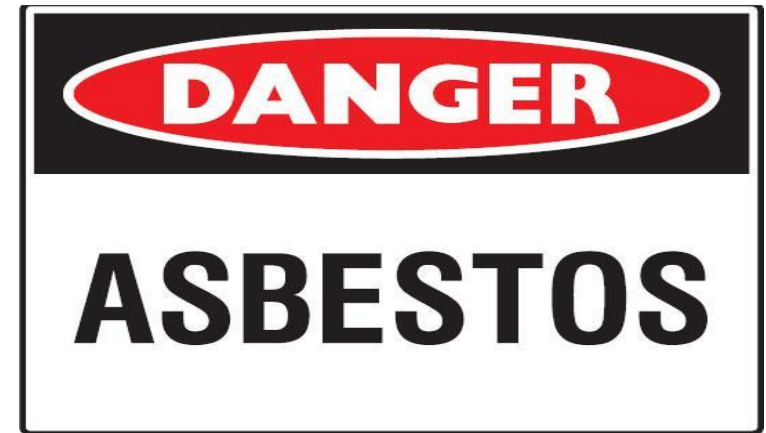

A permit may also be required by the local municipality.
